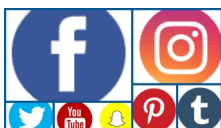

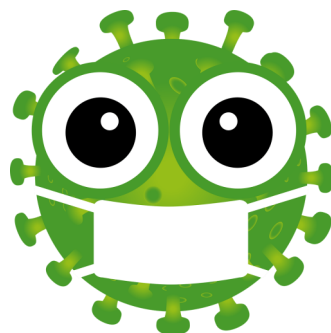


Innovation 2045!

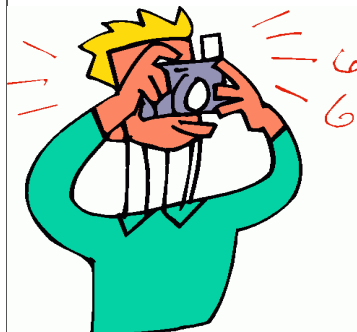
