7. PRESENTATION: First/Final Mile Study Process/ J. Galvin

Mr. Galvin presented information on the First/Final Mile Study Process. He shared information on Public Law 114-94 Freight and The Fast Act, as well as Jason's Law which is why the studies were so important. The three studies are Impacts/Benefits analysis of Truck Access http://www.wilmapco.org/port_analysis, Delaware Truck Parking Study http://www.wilmapco.org/fruckparking, and Delaware First/Final Mile http://www.wilmapco.org/finalmile. Mr. Gavin noted that most trucks on the peninsula aren't stopping for mandated rest, they are parked to wait for their pickup/delivery time. Mr. Gumrot said recently there have been two tractor trailers on Blairs Pond Road, a very rural road. Ms. Powell said she used to own a trucking company and knows that parking spaces are an issue. Ms. Miller said long-haul truckers have an issue parking when they come home.

8. DISCUSSION: DRAFT UPWP / M. Smith (enclosure)

Ms. Smith presented the draft UPWP worksheet to members. Members had some questions, and some items were discussed.

Dr. Collins asked about Woodland Beach being an item on UPWP. Mr. Galvin said they are going to raise it or abandon it. Dr. Cohee said that the more you build it up, the more it sinks. She said that if you are going to live where it floods then it is on you. Mr. Thomas replied to everyone to address the concerns regarding coastal roads. DelDOT is doing data-driven decisions and these studies are about getting the information.

Ms. Miller asked about the Camden Bike/Ped Plan and why it has a question mark. Mr. Galvin said that it's one of those plans that we can do in house. Ms. Smith referred committee members to the updated spreadsheet.
