Mr. Darin Dell - Darin is currently retired from the State of Delaware as of June 2021. His last position was an Application Support Manager for the Crash Analysis Roadway Safety Application (CARS). CARS is used to display vehicle accident locations with related data throughout the state. The application also generated the Highway Safety Improvement (HSIP) report. He also managed the Incident Locator Tool (ILT) application. ILT is used by police officers to geographically locate vehicle accidents and applied to the accident reports. He was responsible for the application maintenance, upgrades, user support and training. Darin was in this position for 10 years. Prior to that he was a Traffic Signal Designer responsible for applying traffic safety studies to the design and build of the intersections. He was in this position for 15 years.
