5. ACTION ITEM: PRESENTATION: DelDOT Equity Tool (https://storymaps.arcgis.com/stories/ac95bc35b5ee4bba85a7b0e5dd78e715) / Jim Pappas, P.E. and Stephanie J. Johnson of Transportation Resiliency & Sustainability

Ms. Johnson gave the presentation. The story map was created in ESRI. Every map was designed to be interactive, shared, and stand on its own. Ms. Johnson is with DelDOT, and her department was created two years ago. Justice 40 was enacted on a federal level, which directs forty percent of federal money to serve Equity Focus Areas (disadvantaged communities). The federal government has many tools to help



states define equity-focused areas. DelDOT felt they could use the tool and improve the information based on local knowledge. Mr. Lyon commented that this is a really cool tool. He asked if it could be used for state loan or grant utilization. Mr. Berry asked about age analysis and made the point that manufactured houses were not necessarily an equity focus. Ms. Wiles asked about including Amish. Ms. Johnson stated this equity tool is not transportation-based, it is population and demographics-based. Mr. Rothwell spoke about census tracts around Newark that are student housing and are very affluent. Ms. Johnson said they noted student housing and apartments. Mr. Pierce asked if municipalities notice something that should be noted, how should they communicate that. Ms. Johnson said you can click on the interactive data and make a note. Mr. Galvin asked since this was put together for IIJA, will it become part of Decision Lens. Ms. Johnson said they are just rolling this out, but a COT action would be required.

6. ACTION ITEM: PRESENTATION AND RECOMMENDATION: Bay Road Study (https://doverkentmpo.delaware.gov/files/2023/07/Bay-Road-Pedestrian-Path-and-Walking-Trail-Study-Draft-6.2023.pdf) / Malcolm Jacob, James Galvin (enclosure)

Mr. Jacob introduced the study. The study aimed to find the current pedestrian network within a halfmile radius around Bay Road. Find the gaps and recommend how to connect the network of walkways. One of the challenges is getting from the east side of Bay Road to the west side of Bay Road. Mr. Galvin pointed out some of the recommendations of the study. Mr. Jordan commented that the VA medical care recently renovated some of the Blue Hen Corporate Center to serve veteran medical care and services to accommodate the Delmarva Peninsula as the VA Center in Elsmere is overused. Mr. Berry noted dangerous spots in Blue Hen Parking lot and wondered about the barriers between the hotel and Blue Hen. He also stated the great connections behind the new DSWA facility. He would like to see sidewalks to the school without losing the tree line. Ms. Gray asked about funding sources. Mr. Jones stated it was a good report and Chesapeake utilities are very supportive to see it move forward.

Ms. Wiles gave a brief presentation on the Public Participation Plan. It is a blueprint for public engagement and a handbook for the PAC. It outlines how we can get every voice heard.
