MEMORANDUM

SUBJECT: Transit Safety Performance Measures & Targets

TO: Technical Advisory Committee

BACKGROUND

On March 6, 2019, the MPO Council adopted certain Transit Asset Management (TAM) Performance Measures as promulgated and adopted by Delaware Transit Corporation (DTC), as required by the Federal Transit Administration (FTA). In addition to the TAM Performance Measures, MPOs are also required to establish Transit Safety Performance Targets that have been adopted by Public Transit Providers such as DTC. There is a total of seven (7) required Transit Safety Performance Targets that include:

- <u>Number of Fatalities</u>: The total number of reportable fatalities by mode
- <u>Rate of Fatalities</u>: The rate of reportable fatalities per 100K VMT by mode
- <u>Number of Injuries</u>: The total number of reportable injuries by mode
- <u>Rate of Injuries</u>: The rate of reportable injuries per 100K VMT by mode
- <u>Number of Safety Events</u>: The total number of reportable safety events by mode
- <u>Rate of Safety Events:</u> The rate of reportable safety events per 100K VMT by mode
- <u>System Reliability:</u> Mean Distance between Maor Mechanical Failures (MMF)

Since Dover Kent MPO is not a Public Transportation Provider it is preferred that for purposes of the Federal requirements, we adopt the Transit Safety Performance Targets enacted by DTC, rather than establishing our own.

Dover Kent MPO has been provided information pertaining to the Transit Safety Performance Management Targets established by DTC (see table below) and seeks to have these adopted by the MPO Council as soon as possible.
