6. PRESENTATION: Cheswold Pedestrian Walkway Study update / Malcolm Jacob

Mr. Jacob had a slide presentation highlighting items in the study. He talked about existing and future conditions affecting safety in the corridor studied. He spoke about public outreach to the community and recommended improvements. Mr. Pierce asked about expanding the study up to Messina Hill Road. There are new developments in the works. Mr. Berry stated there are plans for a sub-division near Lakeshore Village, and a traffic study is in the works. Mr. Pierce asked if DKMPO looked at the connectivity east of 42 near the Royal Farms.

7. ACTION ITEM: PRESENTATION: Transit Safety Performance Measures / Mike Petit de Mange

This was a late item on the agenda. While Mr. Petit de Mange was working on the MTP, it was discovered that the Transit Safety Performance Measures had been adopted by DTC but had not been adopted by DKMPO. Mr. Lyon asked if this would increase the person-hours of DKMPO. Mr. Petit de Mange answered that it would not increase if the measures were used when evaluating projects for the TIP. Ms. Nabeela asked would this pertain to specific studies. Ms. C Smith stated the performance measures are for the transit agencies for reporting purposes. Mr. Thomas noted he thought the memo attached was helpful.

8. *PRESENTATION:* MTP Innovations 2050 overview / Mike Petit de Mange

Mr. Petit deMange shared a presentation regarding the MTP for DKMPO. He gave an overview of the MTP, the MPO Vision statement, the process of updating it, and the timeline the MPO wishes to follow to complete it. Mr. Petit de Mange introduced the themes and goals of the MTP. Ms. Wiles gave an overview of the public outreach. DKMPO will be at festivals, trade shows, local grocery stores, and libraries. She asked those who joined in person to play the money game before they left for the day.

Mr. Lyon stated the Kenton Road project (Route 8 to Chestnut Grove Rd) will begin soon. The area will have lots of detours. Downtown Dover Master Plan has some utility improvements and road redesign. The initial meeting will be happening soon. Mr. Han spoke about the Greenhouse Gas measure that has been established. State DOTs were to adopt in February, and MPOs had six months to adopt. Adoption has been pushed to March 29, 2024. If MPOs have overlapping areas, they need to adopt another target by September.

11.3 Outreach and Environmental Justice/Title VI - H. Wiles

Ms. Wiles noted that DKMPO received a STIC grant and is developing MPO A Virtual Experience. There will be virtual modules related to safety (how to navigate a roundabout, bicycle safety), Think Like a Planner program, MPO 101, and a version of the money game.
