Ms. Smith shared with the Council the amendment moving money in the budget to support transit vehicle air filtration systems.

6. PRESENTATION: Cheswold Pedestrian Walkway Study update / Malcolm Jacob

Mr. Jacob had a slide presentation highlighting items in the study. He talked about existing and future conditions affecting safety in the corridor studied. He spoke about public outreach to the community and recommended improvements. Mr. Sweeney asked about reducing speeds. Mr. Sisson shared that DelDOT is experimenting with fencing on the median to funnel pedestrian walking. Mr. Sisson also stated more lighting is needed. Ms. Steinbach asked that the MPO connect with the traffic section for review, so everyone is on the same page.

7. ACTION ITEM: Transit Safety Performance Measures / Mike Petit de Mange

Mr. Petit de Mange was working on the MTP, it was discovered that the Transit Safety Performance Measures had been adopted by DTC but had not been adopted by DKMPO.

8. PRESENTATION: MTP Innovations 2050 overview / Mike Petit de Mange

Mr. Petit deMange shared a presentation regarding the MTP for DKMPO. He gave an overview of the MTP, the MPO Vision statement, the process of updating it, and the timeline the MPO wishes to follow to complete it. Mr. Petit de Mange introduced the themes and goals of the MTP. Ms. Wiles gave an overview of the public outreach. DKMPO will be at festivals, trade shows, local grocery stores, and libraries.

9. Play the Money game – We need you! / Helen Wiles

Ms. Wiles asked everyone to stop after the Council meeting to play the money game. She explained it is a way to take a survey without taking a survey. We have had 330 people answer the survey and expect to exceed 500 responses.

10. *MEMBER REPORTS*****

Mr. Sweeney stated Kent County had an applicant for a daycare on South State Street Extended. DelDOT approved his entrance permit but Kent County stated a traffic study costing \$50,000 made the entranceway cost prohibitive. Kent County is looking to remove the Adequate Public Facilities

Ordinances for roads and schools. Mr. Sisson cautioned that the MPO cannot lobby. Ms. Smith stated we cannot lobby, but we can provide education/technical assistance.

Mr. Sisson shared that DelDOT with the Office of Highway Safety and Delaware State Police will be hosting a Safety Summit on April 17, 2024, at the Chase Center. It is Highway Safety Week.

Ms. Steinebach called attention to Deputy Secretary Hastings's recent podcast on roundabouts and that it is on their YouTube Channel. Ms. Steinebach asked if the MPO could put a link on its website. Ms. Steinebach also encouraged everyone to watch for the Be Del-Aware campaign.
