- Pedestrian crosswalk at Main St & Commerce St and Main St & Moorton Rd

- ADA curb ramp SE corner of Main St, approximately 165 feet of sidewalk to the east (crosses RR tracks), to and including Post Office driveway
- ADA curb ramp SW corner of Main St to be completed as part of DeIDOT PAR contract, approximately 50 feet of sidewalk on Main St to the west, – approximately 27 feet of sidewalk on Commerce St to the south
