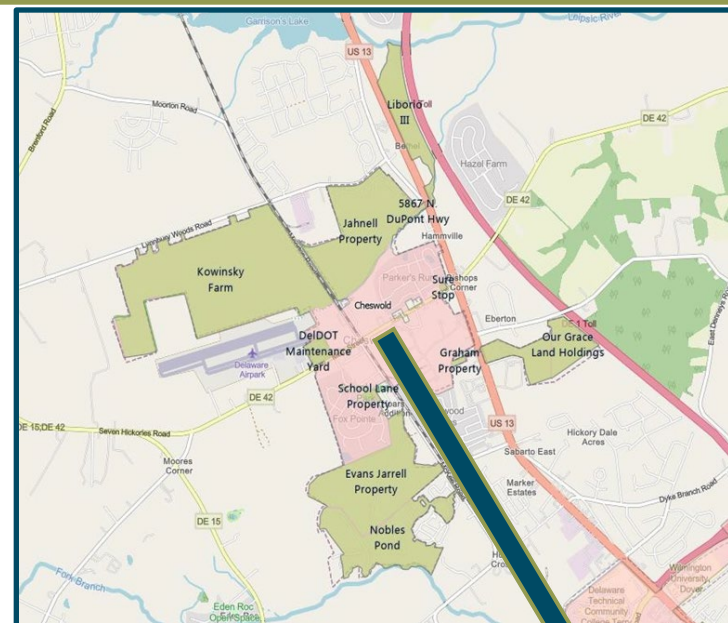

# Project Purpose & Need

Develop recommendations to upgrade the railroad crossing at Main and Commerce Streets in Clayton, DE to provide safe vehicle and pedestrian crossing that is compliant with the federal Americans with Disabilities Act (ADA) requirements.

According to the *Town of Cheswold Kent County, Delaware 2020 Comprehensive Plan*, one of the Town's transportation's goals is to:

“Continue to pursue improvement of the Main Street railroad pedestrian crossing.”

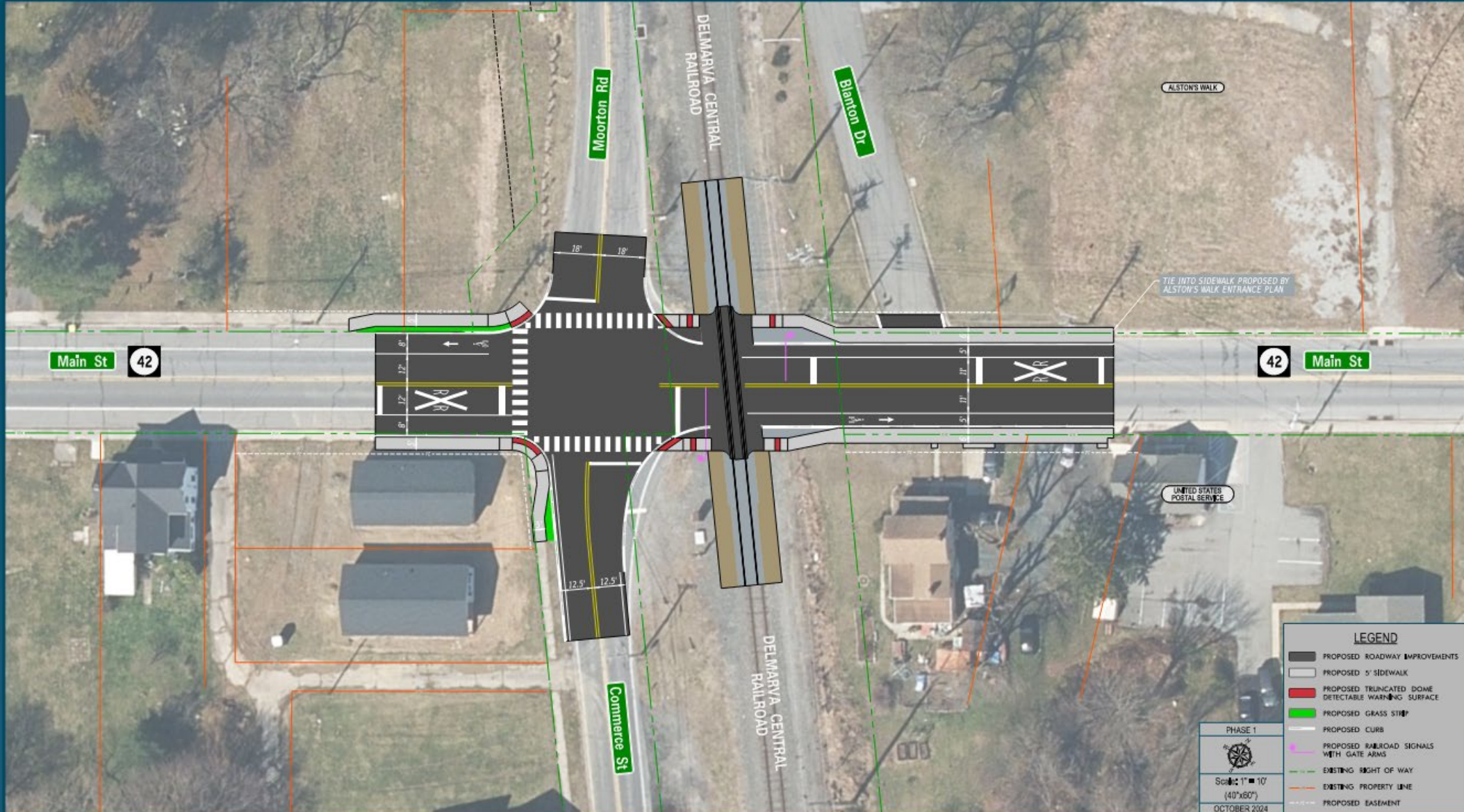
The format of the workshop will be a drop-in open house plans display from 5:00 PM to 7:00 PM.

- Improved & New Sidewalks along Main Street and Commerce Street.

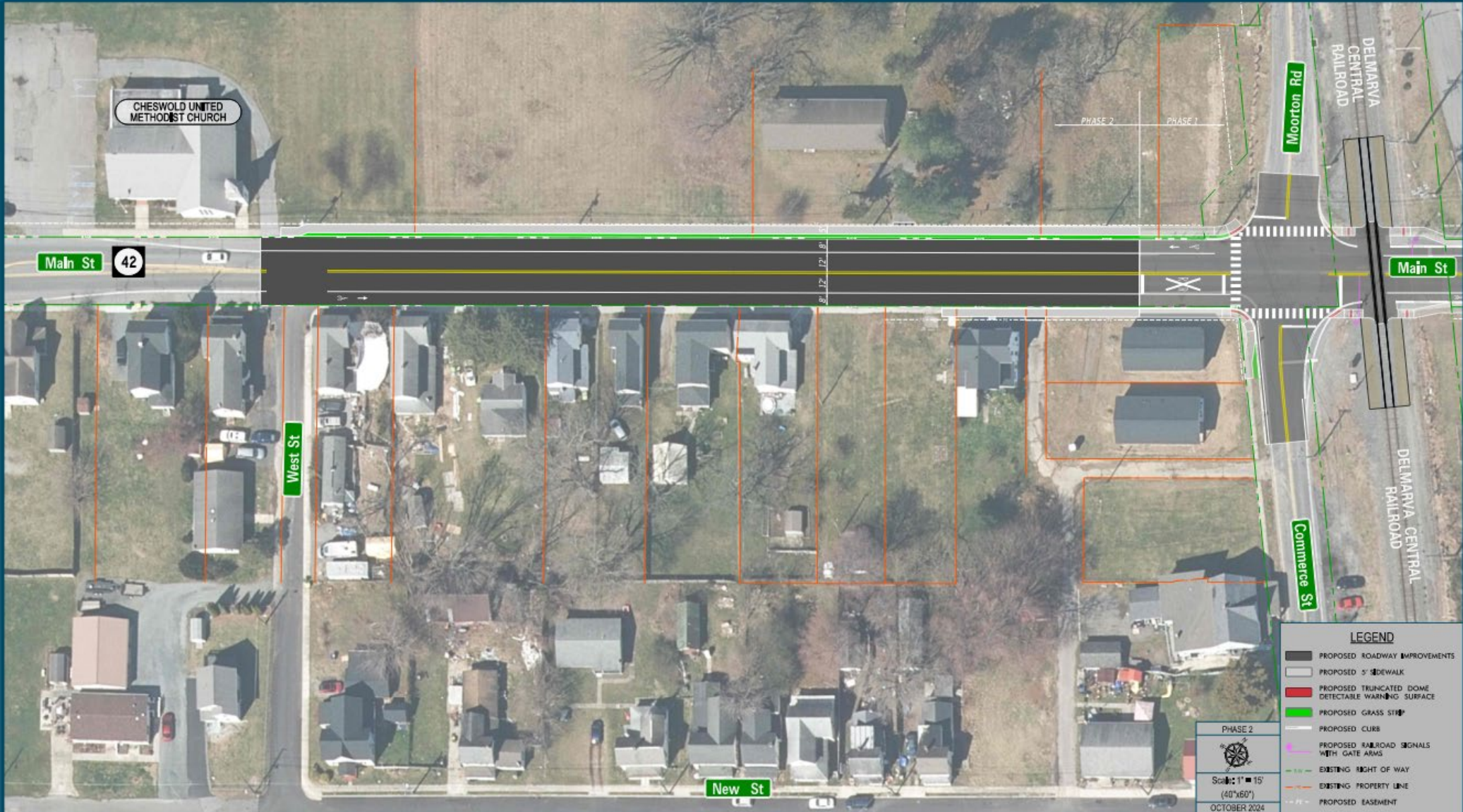


# CHESWOLD MAIN & COMMERCE STREETS PEDESTRIAN RAILROAD CROSSING & SIDEWALKS PHASE 1

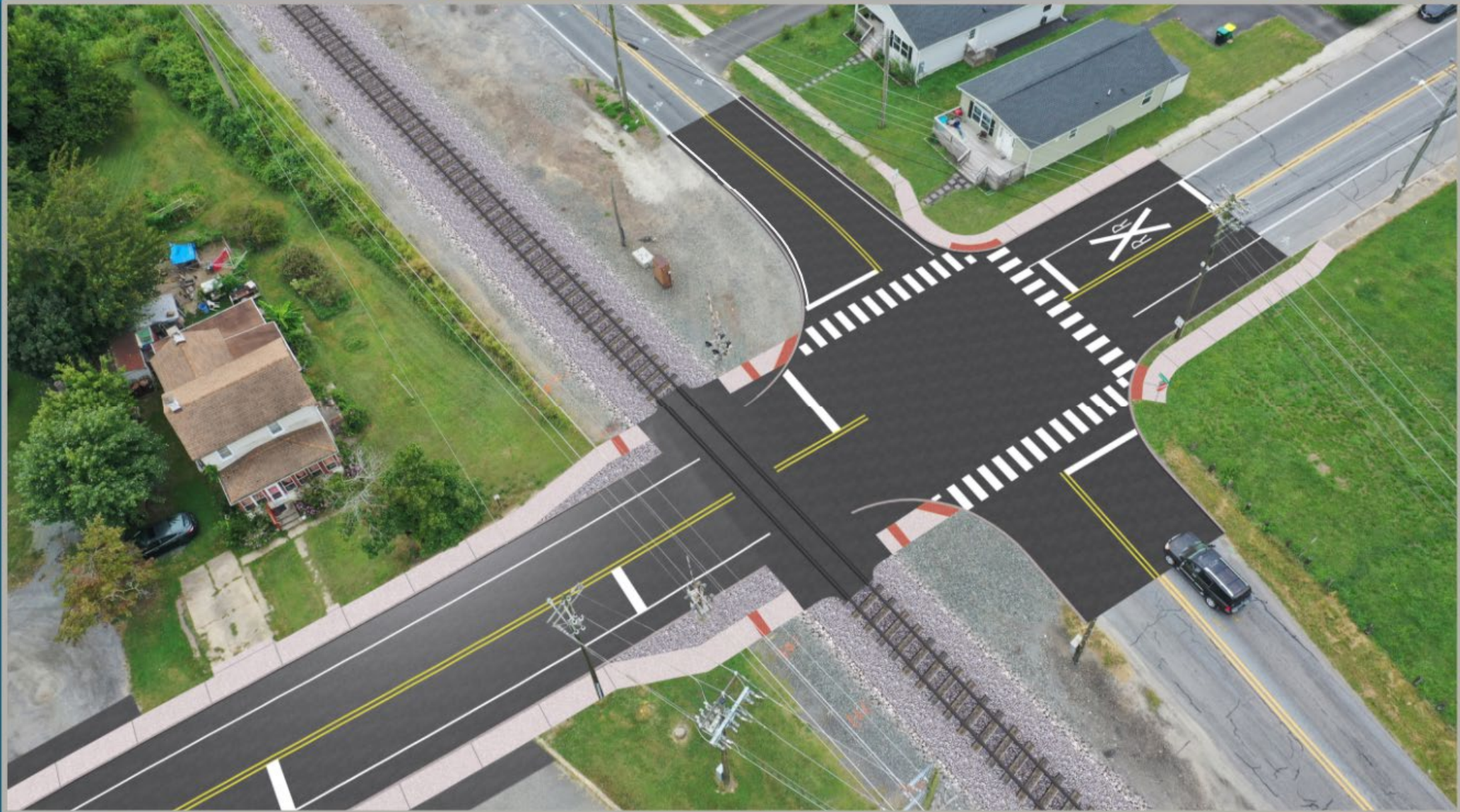

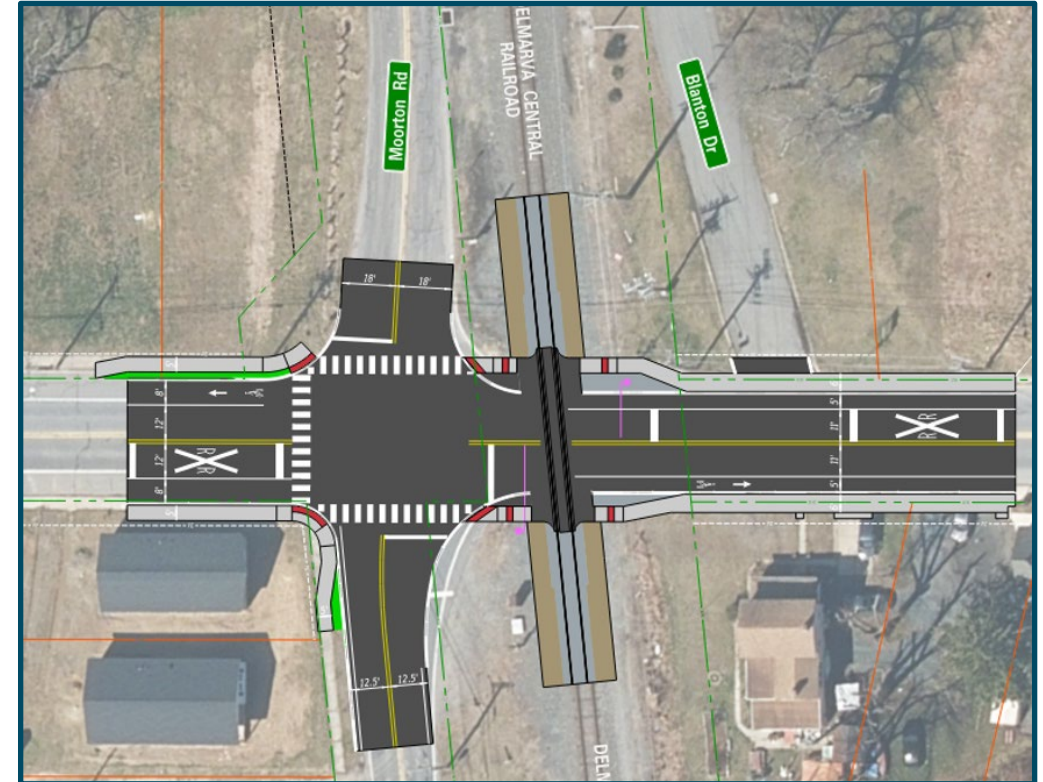




# Costs – Phase 1
