6. ACTION ITEM: FY2024 Whisman Giordano draft audit / Frank DeFroda, Nikolas Reckner (enclosure)

Mr. Reckner presented the FY2024 Audit. He stated everything was consistent with prior years. There is a difference in contracted services, which were down from previous years. There were no material violations or compliance issues. In previous years, there were four recommendations; two have been implemented, and two remain. This was a clean Audit; there were no other significant matters, findings, or issues.

8. ACTION ITEM: South Central Kent County Circulation & Sufficiency (
https://doverkentmpo.delaware.gov/files/2025/05/SC-Kent-Circulation-Sufficiency-Study-FINAL.pdf) / Rossi, Savannah Edwards; M. Smith

PAC and TAC recommended to approve.

Ms. M. Smith introduced the study. She shared that it is a DelDOT project that can be implemented for short-term and medium-term circulation improvements. Ms. Edwards shared that the area is in Kent County, between US 13 and US 1, spanning from Route 10 in the north to Route 14 in the south. Rossi examined crash data, travel volumes, crash hotspots, and new developments in the area. There are recommendations for bicycles and pedestrians, as well as roadway recommendations. Mr. Sweeney shared that there is a new subdivision (Cypress Branch) and a new Caesar Rodney School planned in Kent County. He asked about the intersection of Sorghum Mill and Route 10. He also shared that with roadwork being done on the Camden Wyoming Bypass, many people are using Star Hill, specifically Voshells Mill Road, to avoid construction.

MOTION By Mr. Sweeney to approve the study. Seconded by Mr. Faronea.

9. ACTION ITEM: Dover State Street & South Dover Elementary Intersection

PAC and TAC recommended to approve.

Ms. M. Smith introduced the study and shared that it was prompted when Mayor Christiansen called the MPO and requested assistance with a safety issue at the school. Mr. Cote of Rossi shared that the



challenge is that the morning drop-off and pick-up of students in carpools is causing unsafe conditions for children to and from school. Mr. Cote shared recommendations that can be easily implemented, as well as options that are not immediately needed but can be implemented as the school's needs dictate. Ms. Bryson asked, "What is the Department of Education's responsibility? This is not just an issue at this school! Mr. Sweeney asked if it is contingent upon the school to request assistance with traffic control. Ms. Johnson inquired whether funding could be sourced from the Safe Routes to School program. Ms. Bryson stated that perhaps the Office of Highway Safety could help disseminate the message about pedestrian safety in school zones.

MOTION By Mr. Sweeney to approve the study. Seconded by Ms. Bryson.

Ms. M. Smith presented the FY26 UPWP. She also shared that DKMPO's budget is smaller due to the PL funding distribution formula changing as Salisbury Wicomico no longer receives funding. The redistribution allocated 80 percent of the funding to WILMAPCO, with DKMPO receiving the remaining 20 percent. The MPO is seeking other funding sources.
