Wheatley's Pond Road










Study Area

Wheatley's Pond Rd Corridor between Huntington Dr and Baynard Farm Lane with specific focus on the intersections at School Lane, S Bassett St, and S Rodney St.

Purpose & Need

Develop recommendations to improve the intersections and surrounding roadway network to provide safe vehicle and pedestrian movement.











Revised Study Area Extended to South Existing Shared Use Path



 Shared Use Path Ends at Providence Crossing Development Creating Gap in Pedestrian Network











Extension Creates a Connected Shared Use Path Network














Wheatley's Pond Rd Shared Use Path East Side Providence Crossing to School Lane











- Extend Existing 10' Shared Use Path at Providence Crossing with a Proposed 8' Shared Use Path to Connect at Huntington Dr on East Side of Wheatley's Pond Rd
- Continue Shared Use Path North through School Ln Intersection









Wheatley's Pond Rd Shared Use Path East Side School Ln to Baynard Farm Ln












Wheatley's Pond Rd Sidewalk West Side

Wheatley's Pond Rd Proposed Roadway Widening



- Maintain Existing Travel Lanes
- Widening to Accommodate Left & Right Turn Lanes, Bike Lanes & Shoulders, and Pedestrian Facilities







 Widening to start Approximately 600' South of School Ln to Approximately 300' North of S Rodney St











Wheatley's Pond Rd Typical Sections

Showing extended shared turn lane in front of businesses to ease entrance










Wheatley's Pond Rd Alternate Typical Section




Wheatley's Pond Rd Rail Crossing Improvement

*Costs will be developed for the Rail Crossing Improvement Concept as a stand-alone improvement or will be incorporated into the overall Wheatley's Pond Road Widening Improvement Concept.



 Widening to Accommodate Left Turn Lane and Bike/Pedestrian Facilities












School Ln at Wheatley's Pond Rd



- New Traffic Signal at School Ln and Wheatley's Pond Rd (including Protected Left Turn Phase from Wheatley's Pond Rd to School Ln & Pedestrian Signals)
- New Pedestrian Crosswalks at School Ln and Wheatley's Pond Rd



- New Right Turn Lane from Wheatley's Pond Rd to School Ln
- New Left Turn Ln from Wheatley's Pond Rd to School Ln












School Lane Pedestrian Improvements


 Replace Existing 6' Sidewalk with 10' Shared Use Path on South Side of School Ln from Main St to Wheatley's Pond Rd (sidewalk to remain 5' at spillway)

Design \$284,000

ROW \$50,000

Construction \$1,285,000






S Bassett St at Wheatley's Pond Rd



- Relocation of Approximately 370 feet of S. Bassett St. North, including Replacement of Structurally Deficient Culvert, to Create New Intersection with Wheatley's Pond Rd
- New Pedestrian Crosswalk at S Bassett St & Wheatley's Pond Rd Intersection



- New Right Turn Lane from Wheatley's Pond Rd to S Bassett St
- New Left Turn Ln from Wheatley's Pond Rd to S Bassett St











S. Bassett St. Relocation at Wheatley's Pond Road Conceptual Costs

Design \$525,000

ROW \$750,000

Construction \$2,348,000

*Total \$3,623,000

S Rodney St & Artisan Dr at Wheatley's Pond Rd



- Slight Realignment of S Rodney St to Provide Improved Turning Radius with Wheatley's Pond Rd
- Widen Existing Bridge to Accommodate Two Travel Lanes & Shoulders
- Existing Signal to include Protected Left Turn Phase from Wheatley's Pond Rd to S Rodney St & Artisan Dr and Pedestrian Signals



- New Right Turn Lane from Wheatley's Pond Rd to S Rodney St & Artisan Dr
- Maintain Left Turn Ln from Wheatley's Pond Rd to S Rodney St & Artisan Dr
- New Pedestrian Crosswalks at Wheatley's Pond Rd, S Rodney St and Artisan Dr

Design \$121,000

ROW \$450,000

Construction \$740,000




