Mr. Reigner presented the plan. Mr. Reigner explained that if a municipality wanted to apply for the

Federal Highway Administration's Safe Streets money, it needed to have a safety action plan in place. Mr. Reigner shared the plan overview and goal. Public engagement was achieved through a survey shared at events in Kent County and a Safety Working group formed with multiple organizations and municipalities throughout Kent County. A crash analysis was completed and the results shared. He completed his presentation with recommendations and an implementation plan. Mr. Rothwell asked for full plan. Ms. Smith stated the MPO Council will be having a special session to approve. Mr. Rothwell appreciated the time and effort put into the study. He asked when the next funding cycle is and will DelDOT be putting up the local share?

6. ACTION ITEM: Wheatley's Pond Road Intersections (
http://doverkentmpo.delaware.gov/wheatleys-pond-intersections-town-of-clayton/) / Century
Engineering, Ted Foglietta

Mr. Foglietta presented the study. The study area is Wheatley's Pond Rd Corridor between Huntington Dr and Baynard Farm Lane, with a specific focus on the intersections at School Lane, S Bassett St, and S Rodney St. Century presented recommendations to improve the intersections and the surrounding roadway network. Mr. Foglietta shared that this study had good public engagement, as well as business owners reaching out to share their concerns. Mr. Rothwell asked if a full signal analysis would need to be done for the implementation of these recommendations. The answer was Yes. Mr. Lyon mentioned the Rodney/Artesian intersection is skewed due to a ditch. Mr. Rothwell commented that there is a bridge. Mr. Rothwell commented that this would be a massive benefit to both communities due to growth in the area.

7. ACTION ITEM: East/West Freight Routes (https://doverkentmpo.delaware.gov/east-west-truck-freight-routes-phase-2/) / Century Engineering, Ted Foglietta

Mr. Foglietta presented the study. This is Phase 2 of the study. The purpose is to identify new routes for freight movers to use in Kent County, as some routes are difficult to use. He spoke about community engagement with industry and municipalities. He shared the recommendations and the approximate cost of those recommendations. Mr. Rothwell commented that truck traffic from Katherine Drive to Rt 14 would be an excellent way to disperse traffic. Mr. Pierce stated it is still challenging to go from SR1 south to Milford. Mr. Pierce was concerned with the ranking and scoring criteria. Mr. Rothwell asked about Harrington Industrial Park being in the plan.
